The study recommended that parents should take a leading role in supporting their children's education since they are the primary educators and the initial socializers who expose children to the academic and social world. Parents should set high and realistic expectations for their children's educational achievements, as these expectations can motivate their children to perform well academically.

Longitudinal research on parent-child involvement also indicates that low level of such involvement are indirectly associated with later adolescent alcohol and other drug use, through poor parenting nurturing and involvement in deviant peer friendships (Ary, 2019). In the past, several scholars are interested with the poor academic performance of students. Their study revealed that various factors are responsible for scholastic failure of students, such as low-socio-economic background, student cognitive abilities, school related factors, environment of the home, or the support given by the parents and other family members (Khan & Malik, 2019).
